Mark Zuckerman is president of The Century Foundation. He served in the Obama White House as the deputy director of the Domestic Policy Council, leading teams

on key initiatives, including reducing student debt, increasing accountability at for-profit educational institutions, reducing workplace discrimination, increasing wages for home health care workers, and expanding access to job training. Prior to that, as staff director of the House Education and Labor Committee, he helped win passage of landmark legislation such as the Affordable Care Act; the Lilly Ledbetter Fair Pay Act; the Healthy, Hunger-Free Kids Act; and the Student Aid and Fiscal Responsibility Act.


